新型コロナウイルス関連情報:空港検疫に係る陰性証明書提示に関する新たな施策

令和2年11月4日在ザンビア日本国大使館

10月20日、ザンビア国立公衆衛生研究所(ZNPHI)はザンビア国内の国際空港における新型コロナウイルス感染症対策に係る新たな施策を開始したところ、概要は以下のとおりです(関連資料別添1参照)。関連情報は、当館HP及びFBをご覧下さい。

【ポイント】

- ●ザンビア出国時についても、全ての渡航者は原則出国14日前までの陰性証明書の取得が必要(医療機関の証明書に加え、指定機関による証明書が求められる)。
- ●指定機関による陰性証明書は政府指定の様式を使用する。
- ●渡航者は医療機関でのPCR検査受検後、検査結果を持参の上指定機関へ行き、右 陰性証明書を受領する。
- (別添1によると) 「ザンビア入国時については、入国7日前に取得した陰性証明書を提示」の要あり。

【出国時の陰性証明書】

1 手順

- (1) 医療機関にてPCR検査を受検し、検査結果証明書を受領。
- (2) 医療機関から交付された検査結果証明書及び旅券(旅券番号の提示のため) を持参し最寄りの指定機関へ。
 - (3) 指定機関で政府指定の陰性証明書(別添2参照)を受領。

2 指定機関

ルサカ市内であれば、UTH (University Teaching Hospital) やZNPHI、PHO (Public Health Office) あるいはDHO (District Health Office)

3 交付までの所要時間 申請後、即日発行。

4 陰性証明書の取得推奨時期

14日前の PCR 検査受検を証明 (ご利用航空会社及び渡航先国の陰性証明書有効期限に係る規定については別途ご確認下さい)。

- 5 取得費用
 - 200クワチャ (PCR 検査費用を除く)。
- 6 空港での手続 別添2の書式によれば、空港検疫官による認証を受けることとされる。

【入国時の陰性証明書】

- 1 (別添1によると)「ザンビア入国7日前に取得した陰性証明書を提示」と記載がありますが、当館が ZNPHI に確認したところ従来どおり14日前の取得で良いと説明を受けています。

5.3.2 Mandatory Laboratory Testing for Residents at POE

All travellers entering the country through international borders and airports will be required to provide a negative SARS CoV -2 PCR test result. The test should have been conducted within the previous seven (7) days prior to arrival. Those who do not present a negative SARS CoV -2 PCR test result that is valid for seven days shall be subjected to mandatory testing at their own cost.

5.3.3 Exit screening at POE

Travellers exiting the country at the POE should be subjected to a rapid assessment using temperature check and visual observation for respiratory signs and symptoms suggestive of COVID-19, and should present a valid negative SARS CoV-2 PCR test. Personal details of the traveller including final destination shall be recorded.

5.3.4 Detection of ill travellers at POE

Ill travellers at the POE shall be detected either through:

- self-reporting
- visual observation of individuals exhibiting respiratory symptoms suggestive of COVID-19 (cough, shortness of breath, difficulty in breathing, sore throat and headache)
- body temperature measurement (equal to or above 38°C)

All travellers meeting the case definition for COVID-19 and their travel companions shall be separated from others and escorted to the holding bay while maintaining physical distance (not < 1 meter).

5.3.5 Reporting of alerts of ill travellers at POE

Reporting of alerts of ill travellers shall be conducted on board and upon arrival or exit.

Communication linkages should be maintained between the POE and the District Health Office. The following means of communication shall be used:

- Port health officers shall receive health information documents and reports from conveyance operators regarding the travellers on board, conduct preliminary assessment of health risk and shall provide advice on measures to be taken to contain the risk
- Ill travellers shall be managed according to local guidelines. Contact the relevant authorities in accordance with the guidelines for alert management
- Crew aboard any conveyance with an ill traveller(s) shall inform the point of entry prior to arrival
- Port health officers shall inform district, provincial and national health surveillance systems of ill travellers or suspected COVID-19 cases.
